TERMS & CONDITIONS

AMA Agility Index Program 2023

PARTICIPATION

- 1. Participants need to complete the registration form in order to submit their entries along with the registration fees.
- 2. Right to permit participation is reserved with the Panel appointed for the purpose of AMA Agility Index 2023.
- 3. Only registered companies in India are eligible for registration and entry.
- 4. Registration is accepted from official email IDs only.
- 5. Receipt of entries after the last date of receipt specified may be permitted only at the discretion of Panel.
- 6. The Panel will not be responsible for registrations that are not submitted properly / received late or missing a criteria.
- 7. Registrations will be accepted in English only

SURVEY

- 1. Only employees of the registered company are eligible to appear in the survey.
- 2. The Index scoring will be done based on pre-defined evaluation criteria based upon the collected survey responses. The Index scores thus arrived will be final.
- 3. The parameters for evaluation are subject to revision by the Panel.
- 4. Any program module or dates may be revised as seemed appropriate by the panel of the Program.

INTELLECTUAL PROPERTY RIGHTS

 Participants permit free of cost the use of their name about their participation in the public media (during the course of the program to announce participation, scoring or other communications) and do not have any right to any revenues earned through intellectual property rights generated by the Program, if any.

INCORRECT INFORMATION

- 1. The Panel has the right to ask for proof of information provided / audit the information provided in the registration form. If such a request is made and the participant does not agree, the participant could be disqualified from registration.
- 2. Information received will be treated as confidential and not used for any purpose except for determining Agility Index scores.
- 3. The questionnaire are anonymously filled, individual/ employee wise answers in questionnaire will not be accessible to participating organisations.
- 4. If at any time, any information provided by any participant is found to be incorrect in any manner, then the participant will not be permitted to continue with the Program.
